Part I. General Description

Purpose: To recover any increase in the cost of excess per capita water associated with the

purchase of excess water from the New York City Water Board (NYCWB) beyond

the approved July 1, 2010 rate.

Part II. Computation of the Excess Per Capita Adjustment Surcharge

Calculation: As early as possible after notification of an increase in the NYCWB excess water

rate, the Company shall make a compliance filing to be effective on the same

date of the NYCWB excess water rate increase.

Surcharge Amount: The charge will be expressed in dollars per hundred cubic feet (Ccf) carried to four (4) decimal places, applied to the total Ccf billed and subject to all revenue based taxes.

Formula:
