# 6. Channels for Program Transmission\*

#### 6.1 General

6.1.1	Description
F.	Program transmission channels in connection with loudspeakers may be interconnected at Telephone Company premises to form a network for the distribution of program material to a number of loudspeaker locations.
G.	Program transmission local channels furnished in connection with video transmission channels and used to provide the accompanying audio material, may be interconnected by means of switching equipment at Telephone Company premises, subject to the rates and regulations specified in PSC NY No. 14.
H.	The subscriber may not create additional channels from the facilities furnished by the Telephone Company except that channels provided hereunder may, in accordance with the normal transmission characteristics of such channels, be used by the subscriber, alternately or simultaneously, or to create additional channels for record-ordering, coin-collecting or remote control and indication purposes.
I.	A switch is an operation performed by the Telephone Company at a program operating center whereby an existing section of a program network (interexchange channel, station connection or local channel) is disconnected from or connected to another existing section of a network.
J.	Local channels, station connections and interexchange channels furnished on a monthly basis are considered as existing sections of networks during the periods they are furnished as specified by the customer.
K.	Station connections and interexchange channels furnished on an occasional basis are considered as established at the beginning of each occasion of use and discontinued at the end of each occasion of use and are, therefore, considered as existing sections of networks during the occasion of use.

#### 6.2 Mileage Measurement

#### 6.2.1 General

Where a terminal of the channel is located in the territory of Frontier Telephone of A. Rochester, Inc. ("Frontier"), mileage is measured to the point of connection with the facilities of Frontier, in accordance with Part B, Section 5 of the Product Guide.

#### 6.2.2 Interexchange Mileage

The interexchange mileage is the airline distance (fractional miles being treated as full miles) between the serving central offices of the exchanges in which the terminals of the channel are located. Where there are more than two such exchanges the measurements are made in such a manner as to join all the serving central offices to produce the lowest total rate, the mileage rate for each segment being computed separately.

#### 6.2.3 **Local Channels**

- Two Point Service— The interoffice mileage is the airline distance between serving central Α. offices in ¼ miles (fractional ¼ miles being treated as full ¼ miles) up to 12 miles and in miles (fractional miles, being treated as full miles) for distances greater than 12 miles.
- **Multipoint Loudspeaker Networks**
- 1. Outside of NY Metropolitan Exchange Area— Interoffice mileage is measured in accordance with Section 6.2.3A between the studios serving central office and the serving central office of each receiving station using the shortest distance connecting all serving central offices. For all interoffice mileage associated with multipoint Loudspeaker Networks, the mileage is the sum of the airline measurements so determined.
- Within NY Metropolitan Exchange Area— Interoffice mileage is measured separately in accordance with Section 6.2.3A for each of the following mileage segments. Where more than two zone centers are involved the total interzone mileage is the shortest airline mileage connecting the zone centers.
- Channels to or From Zone Centers are measured from the serving central office of the input station or receiving station, to the zone center of the rate zone in which the stations are located.
- Channels Between Zone Centers are measured from the zone center of the rate zone in which the input station is located, to all other zone centers of rate zones in which receiving stations are located.

### 6.2 Mileage Measurement

# Interoffice Mileage A. Local Channels Between Different Buildings not on the Same Premises— Interoffice mileage applies between serving central offices and a loop charge applies between each customer location and its serving central office. One loop charge applies in each exchange on interexchange channels. One loop and interoffice mileage, if any, applies for a local channel connected to the Telephone Company switching center specified in PSC NY No. 14.

# Multipoint Loudspeaker Network Network Termination— A minimum charge equal to the monthly charge for five terminations applies in each rate zone or exchange in which any receiving station is located, each minimum charge being subject to a minimum term of 12 months.
