For Customers that would qualify under Service Classification No. 1B, the Minimum Charge is \$18.33, exclusive of Gas and Pipeline Costs and Adjustments and Increases in Rates and Charges. For Customers that would qualify under Service Classification No. 1AR, the Minimum Charge is \$8.84, exclusive of Gas and Pipeline Costs and Adjustments and Increases in Rates and Charges. For Customers that would qualify under Service Classification No. 1B-DG, the Minimum Charge is \$33.04, exclusive of Gas and Pipeline Costs and Adjustments and Increases in Rates and Charges.
