**CHARACTER OF SERVICE**

Continuous natural or manufactured gas having a monthly average heating value of not less than 1,000 Btu. per cu. ft. delivered at a pressure of not less than 4 inches nor more than 12 inches.

The charges set forth herein shall be subject to a Gas Supply Charge as explained in General Information, Section 27.

**MERCHANT FUNCTION CHARGE, SYSTEM BENEFITS CHARGE, NEW YORK STATE ASSESSMENT AND REVENUE DECOUPLING MECHANISM**

The charges set forth herein shall be subject to the Merchant Function Charge, System Benefits Charge, New York State Assessment, and Revenue Decoupling Mechanism Adjustment as explained in General Information Section 42.

**WEATHER NORMALIZATION**

The charges set forth herein may be subject to a Weather Normalization Adjustment as explained in General Information, Section 27.

**INCREASE IN RATES AND CHARGES**

The rates and charges under this service classification, including the Gas Supply Charge, Merchant Function Charge, System Benefits Charge, New York State Assessment, Weather Normalization Adjustment, Revenue Decoupling Mechanism Adjustment and minimum charge, are increased pursuant to General Information, Section 28, to reflect the tax rates applicable within the municipality where the customer takes service.

**MINIMUM CHARGE**

\$19.00 effective July 1, 2010, \$21.00 effective July 1, 2011 and \$23.00 effective July 1, 2012 per month, plus applicable Gas Supply Charge, Merchant Function Charge, System Benefits Charge and New York State Assessment.

**SUPPLEMENTAL BENEFIT CREDIT AND/OR HEAP CREDIT**

The Supplemental Benefit Credit and/or HEAP Credit, as described in General Information Section 42.A, shall apply to eligible customers.
