### 13.4 CURTAILABLE ELECTRIC SERVICE (Cont'd)

i) The Company reserves the right to discontinue availability of this Special Provision to any customer whose curtailment performance is unsatisfactory, in the sole judgement of the Company. Performance will be determined to be unsatisfactory if the customer's rate of compliance with notice of curtailment is less than 50% for two consecutive Peak Seasons in which that customer has participated in this Special Provision. The compliance level for each curtailment period shall be defined as the difference between the maximum monthly billing demand and the maximum demand within the curtailment period divided by the difference between the maximum monthly billing demand and the Firm Power Level.

The result above shall be expressed as a percentage. All maximum Kw. values shall be determined on a 15 minute integrated basis.

j) Once this Special Provision is elected, service must be taken under this Special Provision for one calendar year.

# 13.5 <u>ECONOMIC GROWTH INCENTIVE DISCOUNT</u>

The Company has designated 75,000~kW as the maximum qualifying total load that is eligible under this discount provision, which includes all customers served under the Economic Growth Incentive Discount from Service Classification Nos. 3 (Special Provision 3.6) and 13 (Special Provisions 13.5 (A) and 13.5 (B)).

## 13.5 (A)

This discount is applicable to any new S.C. No. 13 customer with demand of at least 500 kW or any existing S.C. No. 13 customer with load growth of at least 500 kW of demand over their current demand who (a) is classified in Standard Industrial Classification - Major Groups 20-51 and 60-89 and (b) has an Energy Efficiency Audit performed at the earliest convenience of the customer and the Company, provided the audit is completed within the first six months of taking service under this provision. Customers will be billed for demand and energy as follows:
