Proceeding on Motion of the Commission as to the Rates, Charges, Rules and

Regulations of National Fuel Gas Distribution Corp. for Gas Service

Dear Secretary Burgess:

In compliance with Ordering Clause 3 of *Order Establishing Rates for Gas Service*, issued and effective on April 20, 2017 ("Rate Order") in the above referenced case, National Fuel Gas Distribution Corporation ("Distribution" or the "Company") submits revised tariff leaves for and addenda to its tariff, P.S.C. No. 9 – GAS. The tariff leaves and addenda submitted in the instant filing, set forth in Attachment A, are issued as of today on not less than one day's notice and have an effective date of May 1, 2017.

This is the first of several filings the Company anticipates in order to effectuate the provisions adopted by the Rate Order. The tariff leaves and addenda submitted primarily contain non-substantive changes, e.g., to the information lines in the header at the top of each page that indicate basic information about each page, updates to reflect currently effective tariff language approved subsequent to the initial tariff filing on April 28, 2016 and/or pagination updates. Principally due to the initial implementation of P.S.C. No. 9 – GAS, it is more administratively efficient to effectuate the Rate Order using a multi-filing approach. The Company discussed this approach with Department of Public Service Staff prior to issuance of the Rate Order, and plans to submit subsequent filings later this week to address substantive changes.

Consistent with Ordering Clause 6 of the Rate Order, the requirements of Section 66(12)(b) of the Public Service Law and 16 NYCRR Section 720-8.1 that newspaper publication be completed prior to the effective date of the proposed supplement is waived.
