Orange and Rockland Utilities, Inc. ("O&R" or the "Company") hereby submits for electronic filing the following tariff leaves proposing revisions to its Schedule for Electric Service, P.S.C. No. 3 – ELECTRICITY ("Electric Tariff").

These tariff leaves are issued December 21, 2015, to become effective on December 22, 2015.

On October 29, 2015, the Company made a filing in compliance with the Commission's Order Adopting Terms of Joint Proposal and Establishing Electric and Gas Rate Plans, issued October 16, 2015, in the above-referenced case ("Compliance Filing"). The Compliance Filing included rate and tariff changes that became effective, on a temporary basis, on November 1, 2015. After discussions with Department of Public Service Staff, the Company is making the following changes to certain tariff leaves contained in the Compliance Filing:

- The provisions for AMI and AMR metering opt out fees contained in General Information Section No. 7, Metering and Billing, were amended to clarify that a customer who requests the removal of either an AMI or an AMR meter will be considered to have opted out of AMI or AMR metering. In addition, a paragraph contained in the Joint Proposal has been added to the Electric Tariff concerning customer notifications related to AMI or AMR metering.
- General Information Section No. 25 – Energy Cost Adjustment ("ECA") has been amended to rename the component of the ECA that provides for the recovery of the incremental revenue requirement associated with Demonstration Projects undertaken by the Commission pursuant to the Commission's Reforming the Energy Vision Track I Order issued on February 26, 2015 in Case No. 14-M-0101.
