Orange and Rockland Utilities, Inc. ("O&R" or the "Company") hereby submits for
electronic filing the following tariff leaves proposing revisions to its Schedule for Gas Service,
P.S.C. No. 4 – GAS ("Gas Tariff").

These tariff leaves are issued December 21, 2015, to become effective on December
22, 2015.

On October 29, 2015, the Company made a filing in compliance with the Commission's
Order Adopting Terms of Joint Proposal and Establishing Electric and Gas Rate Plans, issued
October 16, 2015, in the above-referenced case ("Compliance Filing"). The Compliance Filing
included rate and tariff changes that became effective, on a temporary basis, on November 1,
2015. After discussions with Department of Public Service Staff, the Company is making the
following changes to certain tariff leaves contained in the Compliance Filing:

- General Information Section No. 3.7, Provisions of Gas Service, relating to gas service
and main extensions has been modified to clarify the entitlement allowed when multiple
applicants aggregate their entitlements.
- The provisions for AMI and AMR metering opt out fees contained in General Information
Section No. 6, Metering and Billing, were amended to clarify that a customer who
requests the removal of either an AMI or an AMR meter will be considered to have opted
out of AMI or AMR metering. In addition, a paragraph contained in the Joint Proposal
has been added to the Gas Tariff concerning customer notifications related to AMI or
AMR metering.

- In the Compliance Filing, two options were added to Service Classification ("SC") No. 7 – Natural Gas for Motor Vehicle Usage. Option I was for the sale of compressed natural gas ("CNG") to natural gas vehicles at Company fueling facilities in emergency situations. Option II was a negotiated rate option that allows for interruptible sales or transportation of natural gas to owners or operators of CNG fueling stations. Since Option I is at the Company's discretion, the description of the provisions and the rates applicable to Option 1 has been moved to the SC No. 7 Special Provision section. Further changes to SC No. 7 were made to remove references to Options I and II because the negotiated option remains the only option a customer can opt into for this SC.
- A housekeeping change has been made to correct an error on the chart related to daily under-delivery charges applicable under SC No. 13 in the Compliance Filing. The Company has included the correct chart outlining the applicable daily under-delivery charges.

Conclusion and Notice

The Company hereby requests a waiver of the Commission's requirement to publish notice of this filing since the Company has published notice of the Compliance Filing.
