Dear Secretary Burgess:

SUEZ Group ("SUEZ") is the ultimate corporate parent of United Water Inc. and the following public utility subsidiaries providing service in New York: United Water New York Inc., United Water Westchester Inc., and United Water Owego-Nichols Inc. (together, the "New York Operating Utilities"). SUEZ is a global enterprise with over 80,000 employees operating in 70 countries under 50 different brands. Earlier this year, SUEZ announced that it intended to operate its various businesses under a single brand: SUEZ. Consistent with that effort, the New York Operating Utilities are undergoing name changes. The purpose of this letter is to advise the Public Service Commission (the "PSC") that the name changes set out below became effective on November 9, 2015:

United Water Owego-Nichols Inc.	SUEZ Water Owego-Nichols Inc.

Corresponding changes will be made to bills, signage, vehicles and uniforms during the remainder of this year and early next year.

The New York Operating Utilities will notify their customers of the name change through an outreach program beginning in early November, which will employ digital and print advertising, bill inserts, website and social media postings, and outdoor advertising. The name changes will have no impact on the New York Operating Utilities' customers, who will continue to receive water service under the same rates, terms and conditions as are currently in effect.

Finally, so that the PSC's records accurately reflect the name changes of the New York Operating Utilities, enclosed are copies of various materials filed with, and received from, the New York Secretary of State effectuating the name change. Additionally, the New York Operating Utilities also attach a copy of the notice it will place in newspapers once a week for four weeks beginning the week of November 16, 2015, copy of Supplement's notice of the name change, Adoption Notice 1, and a copy of the bill insert that will go to customers. 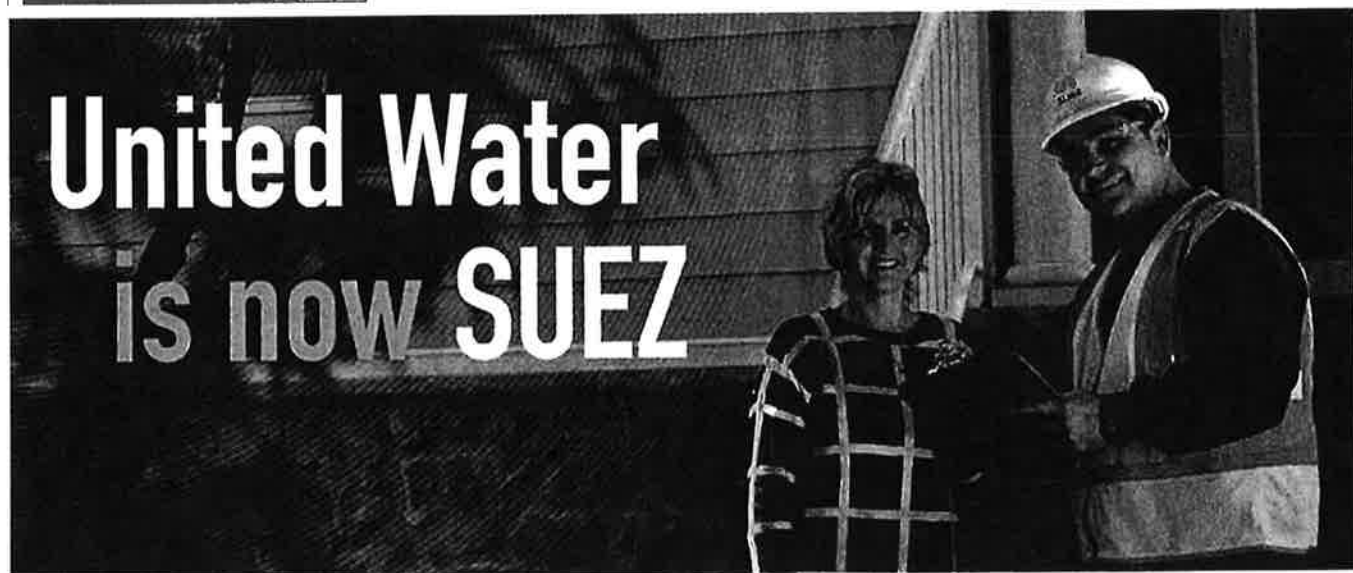

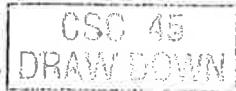


