The enclosed Statements, which are listed below, are issued by Central Hudson Gas & Electric Corporation to become effective on January 13, 2012, the billing date for the eighth batch of the Company's January 2012 billing cycle, and are transmitted for filing in compliance with the requirements of the Public Service Commission of the State of New York regarding changes in adjustments.

Statement of Market Price Charge and Market Price Adjustment	MPC - 132
Statement of Miscellaneous Charges	MISC - 129
Statement of Purchased Power Adjustment	PPA - 129

The factors included in MPC Statement No. 132 are applicable to energy supplied by the Company and are based on the actual commodity costs required to serve the Company's full service customers during the month of December. MPC Statement No. 132 includes Market Price Adjustment (MPA) factors corresponding to the reconciliation of energy costs for the month of September 2011, which were collected through the MPC and for which collections were completed in December. MPC Statement No. 132 also includes charges related to the Company's Hourly Pricing Provision.

The factors included in MISC Statement No. 129 are applicable to all energy delivered by the Company and are intended to refund to or collect from customers the net benefit or cost of non-avoidable, variable energy related revenues and costs associated with the Company's remaining generation facilities and from mandatory purchases from Independent Power Producers for the month of December. MISC-129 also includes a reconciliation component for September 2011 costs/benefits.

The factors included in PPA Statement No. 129 are applicable to all energy delivered by the Company and are intended to refund to or collect from customers the benefit or cost, respectively, of the Company's Purchase Power Agreement with the new owners of the nuclear generating plant previously owned by the Company. PPA-129 also includes a reconciliation component for September 2011 costs/benefits.

Supporting exhibits have been sent to the Commission's staff.
