Dear Secretary Brillling:

In accordance with the Public Service Commission of the State of New York's ("Commission") "Order Approving Transportation and Balancing Collaborative Report Recommendations with Modifications" dated June 23, 2009 and "Order Regarding Tariff Filing Further Revisions – T&B Collaborative" dated January 19, 2010 (Collectively "June 23rd and January 19th Orders"). of KeySpan Gas East Corporation d/b/a National Grid ("KEDLI" or "the Company") hereby submits one copy of: 1) the revised tariff leaves listed in Appendix A to KEDLI's Schedule for Gas Service, PSC No. 1 to become effective on November 1, 2011 and 2) the revised Statement of Seller Charges and Adjustments ("Seller Statement") noted in Appendix B also to become effective on November 1, 2011.

The purpose of this filing is to file revisions to KEDLI's tariff and Seller Statement in accordance with the June 23rd and January 19th Orders to implement daily balancing effective November 1, 2011 and imbalance trading for monthly and daily balanced customers effective December 1, 2011.

Specifically, the Company is modifying its tariff to: 1) terminate the existing daily balancing program; 2) provide customers the option to take either the new daily balancing program or monthly balancing; 3) establish gas delivery procedures for daily balancing; 4) establish cash out provisions for daily balancing; 5) modify cash out provisions for monthly balancing to provide for imbalance trading; 6) establish imbalance trading for monthly and daily balanced customers; and 7) modify forms for gas service to provide for daily balancing. In addition, the Seller Statement is being modified to set forth the charges associated with daily balancing.
