STATEMENT OF INCREASE IN RATES AND CHARGES

Applicable to Billing under all Service Classifications  
of the Schedule for Gas Service of

**ORANGE AND ROCKLAND UTILITIES, INC.**

- (1) **Section 209 of the New York State Tax Law (State Income Tax)** - The applicable rates and charges for service under Service Classification Nos. 1, 2, and 6 of P.S.C. No. 4 GAS, shall be increased by dividing such rates and charges by a surcharge factor of 1.0000 pursuant to General Information Section 15.2.
- (2) **Sections 209-b and 186-c of the New York State Tax Law - (Metropolitan Transportation Authority Business Tax Surcharge)** - The applicable rates and charges for service under all service classifications of P.S.C. No. 4 GAS, including the effect of the surcharge factor shown in (1) above, shall be adjusted by dividing such rates and charges by a factor of 1.0055 pursuant to General Information Section 15.3.
- (3) **Section 186-a of the New York State Tax Law (Gross Receipts Tax), Section 20-b of the General City Law, and Section 5-530 of the Village Law** - The applicable rates and charges for service under all service classifications of P.S.C. No. 4 GAS, including the effect of the surcharge factors shown in (1) and (2) above, shall be increased by dividing such rates and charges by the following applicable surcharge factors pursuant to General Information Section 15.4:
