**Charge for Unauthorized Use**

The charge applicable to unauthorized gas use as defined on Leaf No. 337.0 of the Schedule for Gas Service is the higher of:

- i) Two times the sum of the market gas price as determined in accordance with the Company's Operating Procedures plus the applicable Interruptible or Off-Peak Firm transportation rate; or,
- ii) Nine times the applicable Interruptible or Off-Peak Firm sales rate

\*Applicable Percentage Increase in Rates and Charges are explained on Leaf No. 167.0 - 168.0 and shown on the related "Statement of Percentage Increase in Rates and Charges" for service supplied within municipality where the customer is taking service.
