Whenever a municipality files a petition with the Commission requesting that the water company recover the municipalities' charges for public fire protection service from all customers through a surcharge, and the Commission so orders, the Company will file a new statement. Every such statement shall be filed not less than thirty (30) days before the date on which it is proposed to be effective; shall be applicable to bills subject to the surcharge on the public fire protection infrastructure costs that are rendered on or after the effective date of the statement; and shall be canceled not more than five business days after the surcharge on the costs for infrastructure maintenance and access either ceases to be effective or is modified by law.
