### MUNICIPAL PUBLIC FIRE PROTECTION (MPFP) SURCHARGE

The Municipal Public Fire Protection (MPFP) surcharges are designed to collect each municipality's public fire protection infrastructure costs through a flat per-meter surcharge based on meter size and contribution to utility revenues within each municipality. The MPFP surcharge will exempt customers with internal fire sprinkler systems, private fire protection service customers, and all municipal meters, pursuant to Chapter 433 of the Laws of 2013, as authorized by Commission Order in Case 13-W-0548 et.al. dated March 27, 2014, 14-W-0027 et.al. dated May 14, 2014 and Case 14-W-0100 dated July 2, 2014.

The applicable surcharge amount shall be set forth on statements filed with the Public Service Commission. Whenever a municipality files a petition with the Commission requesting that the water company recover the municipalities' charges for public fire protection service from all customers through a surcharge, and the Commission so orders, the Company will file a new statement. Every such statement shall be filed not less than thirty (30) days before the date on which it is proposed to be effective; shall be applicable to bills subject to the surcharge on the public fire protection infrastructure costs that are rendered on or after the effective date of the statement; and shall be canceled not more than five business days after the surcharge on the costs for infrastructure maintenance and access either ceases to be effective or is modified by law. Such statements will be duly filed with the Public Service Commission and will be available to the public at Company offices at which applications for service may be made.
