**C. Off-Peak Firm Service**

**D. Unauthorized Use Charge**

The charge per therm applicable to unauthorized gas use by interruptible or off-peak transportation customers, as explained on Leaf No. 302 of the Schedule for Gas Service is the higher of:

- i) Two times the sum of the market gas price as determined in accordance with the Company's Operating Procedures plus the applicable Interruptible or Off-Peak Firm transportation rate; or,
- ii) Nine times the applicable Interruptible or Off-Peak Firm sales rate

**E. Capacity Release Service**

The rate per therm applicable to Capacity Release Service is 5.912 ¢/therm

**F. System Loss Factor**

The percentage to be applied to a customer's daily transportation quantity to determine the quantity of gas to be retained by the Company as an allowance for losses is 1.315%
