1. Average Cost of Gas
The average cost of gas per therm (as defined on Leaf Nos. 17 - 17-A) determined on October 25, 1999 by applying the rates and charges of the Company's gas suppliers which will have been in effect not less than fifteen days prior to the date the gas adjustment becomes effective to the quantities of gas delivered to the Company's own Customers during the twelve months ended September 30, 1999, plus the costs associated with non-firm gas supplies is 37.6394 cents
2. Base Cost of Gas
The base cost of gas per therm is 30.0000 cents
3. Difference (Line 1 - Line 2) 7.6394 cents
4. Gas Adjustment per therm before surcharge or refund is (Line 3 x 1.0331) 7.8923 cents
5. The annual surcharge or refund computation (reconciliation) per therm, as explained on Leaf Nos. 17-A-1 - 17-A-2, results in a surcharge of 1.7365 cents
6. Gas Adjustment per therm including the effect of the annual surcharge set forth on Line 5, but before application of rate adjustment credits and surcharges is 9.6288 cents
