1. Average Cost of Gas
The average cost of gas per therm (as defined on Leaf Nos. 17 - 17-A) determined on February 24, 2000 by applying the rates and charges of the Company's gas suppliers which will have been in effect not less than fifteen days prior to the date the gas adjustment becomes effective to the quantities of gas delivered to the Company's own Customers during the twelve months ended January 31, 2000, plus the costs associated with non-firm gas supplies is 34.0093 cents
2. Base Cost of Gas
The base cost of gas per therm is 30.0000 cents
3. Difference (Line 1 - Line 2) 4.0093 cents
4. Gas Adjustment per therm before surcharge or refund is (Line 3 x 1.0331) 4.1420 cents
5. The annual surcharge or refund computation (reconciliation) per therm, as explained on Leaf Nos. 17-A-1 - 17-A-2, results in a surcharge of 1.6848 cents
6. Gas Adjustment per therm including the effect of the annual surcharge set forth on Line 5, but before application of rate adjustment credits and surcharges is 5.8268 cents
7. Reconciliation of prior years' GAC Surcharge to be credited during the period December 1, 1999 through November 30, 2000 (0.9238) cent*
8. Interruptible Sales Credit per therm, as explained on Leaf Nos. 20-B - 20-B-1 is (2.9991) cents*
9. Gas Pipeline Supplier Refunds per therm to be credited during the periods designated below are as follows:
 - (a) April 1, 1999 through March 31, 2000 (0.0651) cent*
 - (b) May 1, 1999 through April 30, 2000 (0.9575) cent*
 - (c) September 1, 1999 through August 31, 2000 (0.0833) cent*
10. Total of gas pipeline supplier refund credits per therm as set forth in Line 9 above is . (1.1059) cents*
11. Credit from Electric and Steam Departments per therm is (1.7274) cents*

- b) New York City Customers - Lines 14 and 15(a) (1.4432) cents***

For all bills rendered bi-monthly, the rate adjustment per therm effective March 1, 2000, and continuing there-after until changed, will be the average of the rate adjustment stated above on Line 15(b) of (1.4432) cents and the rate adjustment effective February 1, 2000 of 0.6023 cent, Line 15(b) of Statement No. 12 of PSC No. 9 - Gas (0.4205) cent***
