The Company shall recover annually \$1,326,620 of CIP costs through December 31, 2010 associated with the multi-family program approved by the Commission in Case 07-M-0548 issued July 27, 2009 through a monthly surcharge to SC 13M and SC 13D, TC 1.1, TC 2.0, TC 3.0, and TC 4.1 Customers (exclusive of customers receiving negotiated rates pursuant to the competitive rate provisions of those rate schedules) of \$0.07957/Mcf.
