SPECIAL PROVISIONS: (CONT'D)

- D. Firm Transportation Service will be provided on a "first call" basis for the available capacity in the Company's distribution system. If other applicants desire Firm Transportation Service and there is only available capacity for the "first" applicant, the "first" applicant can reserve the required available capacity for a period of three (3) months. If deliveries are not commenced within the three-month period, the available capacity will be released for the use of the other applicants.
- E. Customers electing service under this service classification are subject to the Upstream Capacity Requirements set forth in General Information Section 5.I. of this Schedule.
- F. Economic Development Incentive (EDI)

As provided in General Information Section 33 of this schedule, this provision is no longer available to additional customers on or after 10/17/09.

Customers who qualify, under the Economic Development Incentive (EDI) in Section 33 of the General Information section of this Schedule, to receive an incentive for usage qualified on or after 10/01/04 will have their service bills reduced for a term of sixty (60) months. The reduction will be based on the following discount rates by Area for such qualified Therms in excess of the base amount established for each monthly billing period (as described in General Information Section 33 of this Schedule).
