## II. 47. CONSERVATION INCENTIVE PROGRAM ("CIP") COST RECOVERY MECHANISM

The Company shall recover \$276,868 of CIP costs through December 31, 2010 associated with the low income multi family performance program approved by the Commission in Case 07-M-0548 issued June 24, 2010 through a monthly surcharge to SC 13M and SC 13D, TC 1.1, TC 2.0, TC 3.0 and TC 4.1 Customers (exclusive of customers receiving negotiated rates pursuant to the competitive rate provisions of those rate schedules) of \$0.06859/Mcf.

The Company shall recover \$86,683 of CIP costs through December 31, 2010 associated with the EmPower New York program approved by the Commission in Case 07-M-0548 issued June 24, 2010 through a monthly surcharge to the Delivery Adjustment Charge to SC 1, SC 2, SC 2A and SC 3 Customers of \$0.00548/Mcf.

The Company shall recover the following CIP costs through December 31, 2010 associated with the following programs approved by the Commission in Case 07-M-0548 issued June 24, 2010 through a monthly surcharge to SC 13M and SC 13D, TC 1.1, TC 2.0, TC 3.0, TC 4.0 and TC 4.1 Customers (exclusive of customers receiving negotiated rates pursuant to the competitive rate provisions of those rate schedules):
