Daily Swing Service Monthly Imbalance Charge

The Company shall balance the Customer's account after each actual meter reading to zero. This shall be done by comparing the sum of the Customer's deliveries to the Company for the month to the Customer's actual usage for the same period. If the Customer consumed more gas than delivered to the Company for his account, the excess shall be purchased by the Customer at the Company's Monthly Cash Out Price for the same period. If the Customer consumed less gas than delivered to the Company for his account, the shortfall shall be credited to the Customer at the Company's Monthly Cash Out Price for the same period.

Return on Storage Surcharge

Rates for transportation service under this Service Classification shall include each month the Return on Storage Surcharge for Service Classification Nos. 1A, 1AR, 1B, 1BR, 2-1, 2-2, 3, 4A, 4A-CNG, 4B, 7, and 21.

The projected monthly **Return on Storage Surcharge** shall be computed in December 2006 for the Partial Gas Cost Year, and thereafter every August for the following Gas Cost Year for inclusion in the monthly billing for the following Gas Cost Year, shall be computed as follows:

Transportation Customers' Share of the Return on Storage divided by the projected throughput for customers served under Service Classification Nos. 1A, 1AR, 1B, 1BR, 1B-DG, 2-1, 2-2, 3, 4A, 4A-CNG, 4B, 7, 14, and 21.

Transportation Customers' Share of the Return on Storage is the Transportation Customer Share of Throughput multiplied by (1) the Return Requirement Percentage and (2) by the 13-month storage balance

Transportation Customer Share of Throughput – (1) total firm transportation service provided under this Service Classification divided by the sum of (a) total firm sales service to Service Classifications 1A, 1AR, 1B, 1BR, 1B-DG, 2, 3, 4A, 4A-CNG, 4B, 7, 14 and 21 plus (b) total firm transportation service under this Service Classification.

The resultant projected monthly Return on Storage Surcharge for customers served under this Service Classification shall be set forth on the Statement of Unbundled Transportation Service Charges filed monthly with the Public Service Commission.
