GENERAL INFORMATION

SERVICE CLASSIFICATION No. 3 (Continued)

SPECIAL PROVISIONS:

- 1. The service under this classification is available to supply water to permanent underground lawn sprinkling systems installed under Customer' lawn having jets or sprinklerheads attached thereto which will sprinkle the lawn on the Customer's premises when a valve or valves under the control of the Customer are opened, releasing the water pressure to open jets or sprinklerheads. Connections between the lawn sprinkling system and the service line or pipe supplying water for any other purpose is prohibited. A separate service line will be installed to service Applicants for service under this classification.
- 2. Applicant shall enter into a contract with the Company, wherein Applicant agrees to use this service for ten full seasons from date of installation, and to guarantee such agreement, the Applicant shall deposit with the Company, in advance of installation, the cost of the installation of the service from the main to the property line. Said deposit to be held by the Company for ten full seasons. This deposit will bear simple interest at rate per annum presently prescribed by the Public Service Commission. If at the expiration of ten full seasons, the service has been in continuous use for the entire period, the deposit made by Applicant shall be refunded in its entirety. If Applicant discontinues this service at any time prior to ten full seasons, then the Company will charge said deposit with the entire cost of such service, less depreciation at the rate of three per cent (3%) per annum for the period such service has been in the ground and return to the Customer the difference remaining.
- 3. The Customer shall not be permitted to use this service except during the hours of 9 P.M. to 6 A.M. The Company reserves the right to discontinue this service at any time for a violation of this provision. Service which is discontinued for such violation may, at the option of the Company, be refused for the balance of the season and no refund of the minimum charge will be allowed to the Customer.
- 4. In the event of an emergency, the Company may discontinue the service, in which event the Customer will be allowed the proportion of the minimum charge applicable to the time when such service is discontinued, if the amount of water consumed at the end of the season is not in excess of the minimum allowed.
- 5. The Company will furnish and install the entire service from the main to the property line, using a service pipe of 2 inches or less in diameter and furnish and install a meter of not less than 1" in size to record the quantity of water consumed. In no event will a service of a larger size than two (2) inches in diameter be permitted under this classification.
