33. Monthly Cost of Gas Surcharge

A. Definitions

Unless the context otherwise requires, the following definitions shall apply.

Capacity Release Service Adjustment ("CRSA"): The Statement of Gas Costs and Adjustments for customers served under Service Classification Nos. 1A, 1AR, 1B, 1BI, 1BR, 1B-DG, 2, 3 and 21 shall include the CRSA. The CRSA shall be set annually as of November 1st and will reconcile the difference, positive or negative, between the Company's WACOC and the average price of capacity released to marketers serving transportation customers under Service Classification Nos. 17-1A, 17-1AR, 17-1B, 17-1BI, 17-1BR, 17-2, 17-3, 17-4A, 17-4A-CNG, 17-4B, 17-7, 17-14 and 17-21. The Company will estimate the CRSA in advance of each year by determining the total annual cost difference between its estimated WACOC and estimated average price of pipeline capacity released under the Marketer Capacity Program, and will derive a per therm rate by dividing this annual cost difference by the Company's Annual Forecasted Firm Sales. In its Annual Reconciliation Filing, the Company will reconcile its initial estimate of the CRSA with the calculated adjustment based upon its updated actual release rates, actual volume of capacity released, and actual Customer use in therms.

Company's Annual Forecasted Firm Sales: the estimated sales during the Gas Cost Year for customers served under Service Classification Nos. 1A, 1AR, 1B, 1BI, 1BR, 1B-DG, 2, 3 and 21.

Company's Annual Forecasted Firm Sendout: the estimated firm customer requirements during the Gas Cost Year which are the sum of: (1) the estimated sales for customers served under Service Classification Nos. 1A, 1AR, 1B, 1BI, 1BR, 1B-DG, 2, 3, 4A, 4A-CNG, 4B, 7, 14 and 21 **plus**, (2) the Company's estimated quantities of Tier 2 Bundled Winter Sales, Tier 3 Virtual Storage Service and balancing services to be delivered to transportation customers under Service Classification Nos. 17-1A, 17-1AR, 17-1B, 17-1BI, 17-1BR, 17-2, 17-3, 17-4A, 17-4A-CNG, 17-4B, 17-7, 17-14 and 17-21. All of the above quantities are to be multiplied by the applicable Factor of Adjustment.
