(iii) Return of Storage Capacity

ISSUED IN COMPLIANCE WITH ORDER IN CASE NO. 07-G-0299 DATED 08/30/07.

Return Due to Decreased Customer usage:

If a Supplier that has received storage capacity returns Customers to the Company, has Customers transfer to another Supplier or has a reduced storage obligation due to reductions in Customer usage, the Supplier will return the storage capacity associated with the reductions in Customer usage to the Company and transfer the associated storage gas to the Company at the base storage transfer rate. The Supplier shall be responsible for all taxes and pipeline fees associated with moving or transferring the storage gas to the Company. If the quantity of capacity associated with returned Customers does not decrease a Supplier's capacity allocation by at least 2% over the previous allocation, then the capacity allocation will be set at the previous month's quantity.

Return Due to Termination of STBA Agreement:

If a Supplier's STBA Agreement is canceled or terminated, the Supplier will return the storage capacity to the Company and transfer the storage gas to the Company at the base storage transfer rate. The Supplier shall be responsible for all taxes and pipeline fees associated with moving or transferring the storage gas to the Company. The Supplier also authorizes the Company to act on the Supplier's behalf to confirm all nominations necessary to give effect to this clause.

(iv) Required Storage Inventory Levels

In addition to meeting the City Gate balancing requirements set forth <u>infra</u>, Suppliers must maintain the start of the month (SOM) and end of the month (EOM) storage inventory levels as follows:
