4. Hourly Pricing – Mandatory and Voluntary (Cont'd.)

Voluntary: (Cont'd.)

Additionally, Hourly Pricing is voluntary to a customer that is participating in any of the Company's Economic Incentives without a restriction for their Supply Service Option that received the Economic Incentive beginning on or prior to December 31, 2006, and would have otherwise qualified for Mandatory Hourly Pricing. A customer with a restriction for their Supply Service Option (*e.g.*, a customer that qualified for an Economic Incentive prior to July 1, 2003) will be exempt from Hourly Pricing until the term of the customer's Economic Incentive expires. See the chart below stating the portion of a customer's load to which Hourly Pricing option is applicable. Upon the conclusion of their participation in the Economic Incentive, the customer will be subject to Mandatory Hourly Pricing and have two supply options, EPO or Hourly Pricing option, as described below.
