GENERAL INFORMATION

reconstruction or replacement of such mains, service pipes and facilities, said mains, service pipes and facilities shall be reconstructed or replaced by the Corporation responsible for maintenance as hereinbefore provided. However, replacement or reconstruction of mains and service pipes less than two inches in diameter in excess of 75 feet in length heretofore installed and privately owned, shall be governed by the provisions of Rule 3 hereof.

- G. If any Applicant or Customer is of the opinion that any of the rules hereinbefore set forth due to special facts or circumstances are unjust and unreasonable, it may make application to the Public Service Commission for a modification of such rule or regulation.

WHEREAS the Applicant is the owner of property abutting on a street within the territory prescribed by the Company's schedule of water service filed with the Public Service Commission, in which there is no water main within a distance of seventy-five (75) feet from said Applicant's property and has applied in writing for an extension of the _____ inch main by the Company, from a point on _____ street, for a distance of _____ feet to a point on _____ street, and

WHEREAS the Applicant has satisfactorily assured the Company that he will be a reasonably permanent Customer directly connected with said main as extended, and the said Company reserving its right to demand that the Applicant furnish security for the performance of this contract on his part to be performed.

NOW THEREFORE, said Applicant and the Company in consideration of one dollar (\$1.00) by each to the other in hand paid, the receipt of which is hereby acknowledged, and other mutual and valuable consideration, do hereby agree, as follows:

- (1) The said Company will at its own cost and expense extend a _____ main as above set forth and provide, maintain and replace at its own cost and expense all mains, service pipes, service connections and other facilities as same may be necessary within the confines of said _____ street, said cost and expense to include the amounts paid to governmental authorities for permits to do the work required, and all paving charges for the repair or replacement of the street or sidewalk which may be disturbed in the course of such installation that are legally imposed by any governmental authority.
