For excess over	3	therms	68.98 cents per therm

**Rate II – Low Income (Per month)****Applicability:**

To Low Income Customers, i.e., those Customers who are enrolled in the Company's low income program and are receiving a benefit under Supplemental Security Income, Temporary Assistance to Needy Persons, Safety Net Assistance, Medicaid or Food Stamps, or have received a Home Energy Assistance Program grant in the preceding 12 months served under this Service Classification.

For excess over	3	therms	48.69 cents per therm

**Minimum Charge (per month)**

\$14.34 exclusive of the Gas Cost Factor, Merchant Function Charge, Billing and Payment Processing Charge, Monthly Rate Adjustment, Revenue Decoupling Mechanism Adjustment and increase in rates and charges.

**Merchant Function Charge, Billing and Payment Processing Charge, and Revenue Decoupling Mechanism Adjustment**
