## SCHEDULE A

### SERVICE-POINT DISTRIBUTION SERVICE (Cont'd)

#### SPECIAL PROVISIONS: (Cont'd)

##### Service Classification No. 12 Power for Jobs Rate (Cont'd)

**8. Charges to the Distribution Customer:** The Distribution Customer will pay the Distribution Provider for the following charges:

- A.** NYPA charges for power, energy and transmission (including any minimum demand charge), which are billed by NYPA to the Distribution Provider. The Distribution Provider shall charge the Distribution Customer for demand and energy at rates equal to those charged by NYPA to the Distribution Provider for power delivered under the Power for Job program. These rates will be applied to the NYPA Demand and NYPA Energy calculated in Section 7.A.2 and Section 7.B.1. These charges shall include the cost of transmission and ancillary services to the Distribution Provider's distribution system. Because the rates charged by NYPA to the Distribution Provider may be revised by NYPA upon 30 days' prior written notice, the Distribution Provider has the corresponding right to reflect such changes automatically as they occur, without prior notice to the Distribution Customer. The Distribution Provider shall notify the Distribution Customer of any such change in the next billing for which such notification is feasible.
- B.** The Distribution Provider's charges for delivery of the NYPA power. The delivery rates per kW per month, which vary by Parent Service Classification will be applied to each kW of NYPA Billing Demand, as calculated in Section 7.A.2, above. The rates are specified below:

- C.** The Monthly Customer Charge. This charge shall reflect the Distribution Provider's incremental billing and administrative costs associated with providing Power for Jobs service. The Monthly Customer Charge shall be \$30.00 per month, exclusive of any other rates and charges (including any Customer Charge for the Parent Service Classification).
- D.** The Distribution Provider's charges for delivery of the portion of the power used at the Retail Customer service point that is not provided by NYPA. These rates are listed in Appendix A for the appropriate parent service classification and are applied to the Distribution Customer's Billing Demand and Distribution Customer's Billing Energy, as calculated above in Section 7.A.3 and 7.B.2, respectively. The Distribution Provider's charges for delivery will include the applicable Minimum Monthly Demand Charge from the Parent Service Classification, even if the Distribution Customer's Billing Demand is zero.
