# B. ALLOWANCES FOR THE PROVISION OF ELECTRIC SERVICE (Cont'd)

# (2) Allowance for Non-mandatory Residential Underground Service

Where a Distribution Customer requests a residential underground service line in situations other than those described in (1), the cost and expense which the Distribution Provider must bear shall be equal to the material and installation costs for which the Distribution Provider would have been responsible if the Distribution Customer or its Retail Customer had received overhead service under Rule 6.B.(3). measured from the Distribution Provider's existing electric system (from the connection point on the bottom of the riser pole for overhead to underground connections) to each Retail Customer's meter or point of attachment with respect to each residential building.

#### (3) Allowance for Residential Overhead Service

Where the Distribution Provider is permitted to provide residential overhead service, the costs and expenses which the Distribution Provider must bear shall be equal to the material and installation costs for up to 500 feet of single phase overhead distribution line and up to 100 feet of service line.

# (4) Allowance for Elective Residential and Non-residential Underground Service

Where the Distribution Provider chooses to provide residential or non-residential underground service, the costs and expenses which the Distribution Provider must bear shall be equal to the material and installation costs relating to the necessary Distribution Provider facilities that exceed the amount which the Distribution Customer would be required to pay if such facilities were installed overhead.

# (5) Provision of Mandatory or Non-mandatory Non-residential Underground Service

Where the Distribution Provider is requested to provide a non-residential underground service line by a Distribution Customer, or where a governmental authority having jurisdiction to do so requires undergrounding, the costs and expenses which the Distribution Provider must bear shall be equal to the material and installation costs equivalent to those contained in Rule 6.B.(6) in connection with the provision of non-residential overhead service.

### (6) Allowance for Non-residential Overhead Service

Where the Distribution Provider chooses to provide non-residential overhead service, the costs and expenses which the Distribution Provider must bear shall be equal to the material and installation costs for up to 500 or 300 feet of overhead distribution line, for single-phase and three-phase service, respectively.
