(G) Standby Capacity Charge - Continued

When the aggregate Maximum Quantities of firm customers served by a Seller increases during the winter season, the Company will apply such increase to the secondary capacity requirement and the Standby Capacity Charge will be increased accordingly, for the remainder of the winter period, unless the Seller provides prior written notice to the Company that such increase is provided for under non-recallable firm transportation contracts with primary delivery point capacity from the source of the gas supply to the Citygate, in accordance with the pre-submitted Con Edison Affidavit of Firm Transportation. If a Seller ceases service to its firm customers at any time during the winter season, the Seller's obligation for payment of the Standby Capacity Charges discussed herein shall become immediately due and payable.

Standby Citygate Charge

The Seller shall pay a Standby Citygate Charge for gas supplied by the Company on any day due to a curtailment by the pipeline of Seller's firm transportation with secondary delivery point capacity. The Standby Citygate Charge shall be equal to the Citygate cost of gas, less the Standby Capacity Charge, and shall be applied to the therm difference between the required quantity and the daily transportation quantity applicable to secondary delivery point capacity. The calculation of the Citygate cost of gas is explained in the Company's Sales and Transportation Operating Procedures. The required quantity is defined as either the Daily Load Following Service Quantity, the Daily Load Quantity, or the Revised Daily Load Quantity, as applicable, to the extent that a Seller utilizes secondary delivery point capacity to the Citygate for such Quantities.

(H) Increase in Rates and Charges:

The rates and charges under this Service Classification will be increased by the applicable percentage, in accordance with General Information Section VIII.
