SEASONAL GAS AIR CONDITIONING RATE

APPLICABLE TO USE OF SERVICE FOR:

Consumption of natural gas by non-residential Customer where the gas is used directly in natural gas air conditioning equipment.

RATE: (Per Month)

Service under this Service Classification will be provided at different rates for summer and non-summer consumption. For the months of May, June, July, August, and September, the rate shall be as follows:

First	1,000 cu. ft. or less	\$19.62
All Over	1,000 cu. ft. per 100 cu. ft.	.17001

The base cost of gas for all consumption during May, June, July, August and September is equal to the commodity base cost of gas of \$0.157130 per 100 cu. ft. which is equivalent to the Base Cost of Gas of \$0.153516 included in Section II.19 increased by the loss factor of 2.30% (as established in Case 98-G-1291).

For all other months the rate shall be as follows:

First	1,000 cu. ft. or less	\$19.62
Next	49,000 cu. ft. per 100 cu. ft.	.55157
Next	950,000 cu. ft. per 100 cu. ft.	.49342
All Over	1,000,000 cu. ft. per 100 cu. ft.	.46095

UTILITY LOW INCOME ENERGY EFFICIENCY PROGRAM (ULIEEP) SURCHARGE:

The rates in this Service Classification shall be increased by the ULIEEP surcharge, as described in General Information Section 39.

GAS ADJUSTMENT:

The charges set forth herein, including charges specified under Special Provisions of this Service Classification, shall be subject to a gas adjustment per 100 cubic feet of gas supplied hereunder when changes from Base Cost of Gas occur (as explained on Leaf Nos. 74-84).

WEATHER NORMALIZATION ADJUSTMENT:

Natural gas air conditioning rates shall be subject to a refund/surcharge per 100 cubic feet as set forth in Section 36, General Information.
