Terms of Payment

Bills shall be rendered net cash, January 1<sup>st</sup>, April 1<sup>st</sup>, July 1<sup>st</sup> and October 1<sup>st</sup>, in advance, and are due and payable upon receipt. Bills not paid within 23 days of mailing are delinquent and the late payment charge becomes applicable and service may be discontinued after proper notice as required by law.

Late Payment Charge

A late payment charge to be computed at the rate of 1 1/2 percent per month, compounded monthly, may be applied to all balances left unpaid 23 days following mailing of the bill.

Term

Terminable by the customer upon 10 days' written notice to the company.

Provision:

Special Seasonal Service shall mean metered and unmetered water service provided to a customer during a period after notice to the company by the customer that such customer shall not be using water service during a period of not less than 2 consecutive months during which time the service shall be

deemed to be reconnected for a rec-connection fee as provided in 17. Use of water during such period shall require full payment of the water service charge plus the re-connection fee.
