**RESIDENTIAL FIRM AGGREGATION TRANSPORTATION SERVICE (CONT'D)**

**SPECIAL PROVISIONS: (CONT'D)**

- D. Firm Transportation Service will be provided on a "first call" basis for the available capacity in the Company's distribution system. If other applicants desire Firm Transportation Service and there is only available capacity for the "first" applicant, the "first" applicant can reserve the required available capacity for a period of three (3) months. If deliveries are not commenced within the three-month period, the available capacity will be released for the use of the other applicants.
- E. A Transportation Service Agreement shall be signed by both parties in the form set forth in General Information Section 16 of this Schedule.
- F. Customers that heat any building, including apartment houses, prisons, dormitories, nursing homes, hospitals, hotels, and other buildings where persons may dwell on permanent basis, solely with natural gas delivered hereunder shall be considered "critical service" customers. Effective October 1, 1994, non-daily metered customers must elect reservation of the "Sales Customer" status and daily metered customers must elect either reservation of the "Sales Customer" status or Standby Sales Service, unless the Customer or the Customer's designated agent has adequate primary point firm transportation or a combination of primary point firm transportation and firm storage, or firm gas supplies, to the Company's citygate sufficient to meet one hundred percent (100%) of the Customer's critical needs.
- G. Migration of customers in years 1996, 1997 and 1998, shall be limited to twenty-five percent (25%) per year of the 1995 residential customer base load of 24,019,660 dekatherms.
- H. Customers choosing to move among aggregation pools may do so only between April 1 and April 30 of a calendar year, and on thirty (30) days prior written notice.
- I. For non-daily metered customers, the Company will perform an annual reconciliation whereby gas delivered by the Customer's designated agent in excess of the corresponding aggregation customer's consumption will be rolled over to the next year, and aggregation customer consumption in excess of the designated agent's deliveries will be billed to the Customer's designated agent at the Customer's corresponding sales price.
