GENERAL INFORMATION

5. CONDITIONS OF GAS SERVICE:

- A. Commencing October 19, 1984 and continuing thereafter until further order of the PSC, new gas customers will be connected and increased gas will be supplied to existing customers in accordance with Section 10 of PSC No. 30 Gas, or superseding issues thereof.

Except as otherwise specified in this Schedule, service provided hereunder is in accordance with the applicable provisions of PSC No. 30 Gas, or superseding issues thereof.

B. Incremental Facilities

Customers shall be responsible for the acquisition of any property rights necessary to accommodate the construction and installation of facilities which may be required for the receipt, delivery or metering of natural gas delivered hereunder into the Company's pipeline system. The Company shall be reimbursed by the Customer for any costs incurred in the construction and installation of the required receipt or delivery facilities, including, but not limited to, the costs of labor, materials and customary overheads. Customers subject to balancing provisions under General Information Section 4 of this Schedule are required to install daily metering equipment. The Company will be reimbursed by the Customer for required metering and load management equipment at the Customer location.

C. Nomination and Scheduling

Prior to the start of each month (the exact lead-time depends upon specific arrangements required by the pipelines involved, producers, etc.), the Customer or his designated agent will advise the Company of the daily quantity of gas to be transported during the next monthly period. Failure to notify the Company will cause the daily nomination to go to zero (0) DT/Day for the next monthly period.

Customers may renominate or change the daily quantity (subject to capacity limitations and the requirements of the Company's upstream pipeline(s)) of gas to be transported during any monthly period. Intra-month nomination changes are due to the Company by 12:30 PM one (1) day prior to the day the change is to take effect to allow Company dispatchers to make the necessary arrangements with other gas controllers to effectuate deliveries. Notice may be given by telephone.

Except weekends and holidays, the Company may accept mid-day changes in nominations, provided such changes can be confirmed by all affected upstream pipelines.
