"Daily Price Survey" for "Appalachia," "CNG North Point," plus associated variable transportation costs to the Company's City Gate. The DSS Supplier shall be responsible for all taxes and pipeline fees associated with moving or transferring the storage gas to the Company.

If a DSS Supplier's DSS TBA Agreement is canceled or terminated, the Company will recall storage capacity that has been released to the DSS Supplier. The Company shall have the right but not the obligation to purchase the remaining storage gas at the lesser of (a) 95% of the Company's lowest monthly weighted average commodity cost of gas during the previous injection period (April through October), plus associated variable transportation costs to the Company's City Gate and storage demand capacity charges on such volumes since April 1; or (b) 95% of the Market Price of gas for that day which shall be determined by reference to The Gas Daily Index, "Daily Price Survey" for "Appalachia," "CNG North Point," plus associated variable transportation costs to the Company's City Gate and storage demand capacity charges on such volumes since April 1. The DSS Supplier shall be responsible for all taxes and pipeline fees associated with moving or transferring the storage gas to the Company.

c. Determination of Daily Delivery Quantities and Aggregate Daily Delivery Quantities

The Company, based upon each Public Assistance Customer's historical load profile and/or estimates of consumption, shall determine a DSS Supplier's projected normalized consumption for a given period; either monthly, weekly, or daily. Based upon this projected consumption, the Company will determine each Public Assistance Customer's Daily Delivery Quantity (DDQ) and, by summing all DDQs of the Public Assistance Customers in the DSS Supplier's DSS Group, the DSS Supplier's DSS Group's Aggregate Daily Delivery Quantity (ADDQ). The DDQs and ADDQ so calculated will be used to determine the DSS Supplier's daily delivery obligations, and the specific balancing rates and charges as outlined in this rate schedule.

A DSS Supplier taking service under this Rate Schedule accepts the Company's calculation of the DDQ and/or ADDQ. The Company shall not be liable for the difference between the projected consumption and the consumption determination by the Company.
