SERVICE CLASSIFICATION NO. 8 (Cont'd.)**RATE - FIVE PART - MONTHLY:**(1) Transportation Charge

First 100 Mcf or less \$150.00 per monthly billing period
Next 4,900 Mcf at the Base Charge plus 50 cents per Mcf
Next 5,000 Mcf at the Base Charge plus 25 cents per Mcf
Over 10,000 Mcf at the Base Charge

The Base Charge per 1,000 cubic feet (Mcf) shall be established each month at the Company's discretion, not less than three working days prior to the first day of the billing period for which such Base Charge is to be effective.

The Base Charge shall not be less than five percent of the Company's "Average Commodity Cost of Gas" plus a take or pay surcharge as provided for in the Commission's Order dated March 29, 1989 in Case 88-G-062 for the month in which the Base Charge becomes effective as determined in accordance with the provisions of Service Classification No. 3 of this Schedule.

The Base Charge shall not be greater than (i) the lowest per unit charge for service under Service Classification No. 2 of this Schedule; minus (ii) the "Base Cost of Gas" times the "Factor of Adjustment," both as provided for in General Information Section 12.1 of this Schedule; plus (iii) the "Credit for Interruptible and Firm Dual Fuel Sales and Transportation Service Benefits" included in the "Gas Adjustment Charge" applicable to Service Classification No. 2; minus (iv) 50 cents per Mcf.

(2) Utility Low Income Energy Efficiency Program (ULIEEP) Surcharge

The transportation charge as provided for above in Part (1) shall be increased by the ULIEEP surcharge as described in General Information Section 23.

(3) Supplemental Sales Charge

The rate for all Mcf delivered to a customer in excess of the amount of customer owned gas shall be the "Unit Charge" for service rendered under Service Classification No. 3 of this tariff, but not less than the "Average Commodity Cost of Gas" plus a take or pay surcharge as provided for in the Commission's order dated March 29, 1989 in Case 88-G-062 for the month in which service is rendered.
