Credit information to be provided shall include late payment charges assessed and/or disconnections required.

The Company's customer account number for each customer will be accepted as verification of a customer's consent to release the above information to a Qualified Seller or customer's designee.

The Company will not disclose a customer's billing, credit and/or gas usage history if the customer has notified the Company in writing that such information should not be disclosed. Thereafter, the information will be released only upon receipt by the Company of the customer's written authorization.

All customer information including Company account number, telephone numbers, service address, gas usage and billing history obtained by a Qualified Seller must be kept confidential and not disclosed to others unless authorized by the customer in writing.

10.3 CHARGES FOR OTHER SERVICES

Charges are made for all other special services rendered, which charges are composed of Company costs of labor, direct supervision, insurance, transportation, applicable overheads on the above, plus repair parts at current list prices.
