f. Customers formerly receiving service under Service Classification No. 4 will be grandfathered as of June 1, 1996.

g. Existing customers receiving transportation service under Service Classification No. 7 Non-DCA will continue receiving service under this service classification. These customers will have the option of electing Pooled Aggregation Service as set forth in Service Classification No. 11, or may receive transportation service on a stand-alone basis, commencing on June 1, 1996.

h. Existing customers receiving transportation service under Service Classification No. 7 DCA will continue receiving service under this service classification. These customers will have the option of electing Balanced or Basic Aggregation Services as set forth in Service Classification No. 11, or may receive transportation service on a stand-alone basis, commencing on June 1, 1996.

i. Existing customers receiving transportation service under Service Classification No. 5 Firm Non-DCA will continue under this service classification. These customers will have the option of electing Pooled Balancing Services as set forth in Service Classification No. 11, or may receive transportation service on a stand-alone basis, commencing on June 1, 1996.

j. Existing customers receiving transportation service under Service Classification No. 5 DCA will continue under this service classification. These customers will have the option of electing Balanced or Basic Aggregation Services as per Service Classification No. 11, or may receive transportation service on a stand-alone basis, commencing on June 1, 1996.

k. Existing customers receiving transportation service under Service Classification No. 5 Interruptible will continue receiving service under this service classification. These customers will have the option of electing Pooled Balancing as set forth in Service Classification No. 11, or may receive transportation service on a stand-alone basis, commencing on June 1, 1996.

l. Existing customers receiving transportation service under Service Classification 8 will continue receiving service under this service classification.
These customers will have the option of electing Pooled Balancing as set forth in Service Classification 11, or may stand alone, commencing on June 1, 1996.

m. Existing customers receiving transportation service under Service Classification 9 will continue under this service classification. These customers will have the option of electing Pooled Balancing as set forth in Service Classification 11, or may stand alone, commencing on the June 1, 1996. Service Classification No. 9 customers, with contracts with an effective date prior to June 1, 1996, will have to amend their existing service agreements in order to participate in Pooled Balancing.
