## TERM:

One year and from year to year thereafter until canceled at the end of any one year term by either party upon ninety (90) days's prior written notice to the other, provided, however, that for new installations, Company may require a longer initial term not to exceed five (5) years.

## SPECIAL PROVISIONS:

- A. Written application for service upon a Form "M" executed by a duly authorized representative of the customer is required, to which shall be attached a schedule, designated Schedule "SL", listing the facilities, lamps and lumin aires to be supplied initially. Such application and attached schedule, when accepted by Company, shall constitute an agreement between customer and Company, subject to the terms and conditions set forth in this Service Classification. There will be one Form "M" per customer which shall constitute a single account and multiple street lighting districts shall be included in a single account.
- B. Except when installed as provided in Section I under RATE, any equipment installed hereunder either to replace an existing lamp, luminaire or pole, or to provide additional lighting service, shall be of a type standard with Company at the date of installation.
- C. Company shall not be obligated to replace equipment installed hereunder or under a superseded rate schedule, prior to 15 years from the date of initial installation. New equipment will be installed under the following conditions:
  - 1. Relocation of Existing Facilities

The Company will relocate its street lighting facilities provided that the customer pays the Company the actual costs incurred by Company. The cost shall include all labor, material and other charges applicable thereto, including a reasonable allowance for engineering superintendence, purchasing and the use of construction equipment.

## 2. Additional Lamp Locations

Additional lamp locations will be installed upon the customer's written request. Such written request will be appended to customer's "Form "M" Contract, Application for Service." Customer shall include with such written request a revised Schedule "SL", each executed by a duly authorized representative of the customer.

3. Increase or Decreased Illumination and Conversion of Existing Lamps to Different Lamps.

The alteration of existing equipment for increased or decreased illumination or for a conversion to a different type of lamp will be made at Company's expense if the existing facilities have been in service 15 or more years. If the customer wishes to have one conversion prior to this time, the customer may be required to pay Company the depreciated book cost less net salvage value of the facilities removed. Net salvage value is defined as the removal cost less the salvage value of the Company equipment removed.
