## GENERAL SERVICE (Cont'd)

## **TERM**

Terminable at any time provided that customer cannot resume service within twelve months at the same location without paying the reconnection charge set forth in General Information, Section 22.

## SPECIAL PROVISIONS

The numbering of the paragraphs hereunder begins with the above service classification number.

- 2.1 <u>Secondary Service with Primary Metering</u> (The availability of this provision is limited to existing customers at the locations served as of the effective date of this tariff). When a customer takes service at a secondary distribution voltage, but the Company elects to meter service at the primary distribution voltage, energy charges will be billed in accordance with the rate for primary service. This provision will not apply, however, when the customer installs primary circuits because of the nature of his installation and the Company provides necessary transformers on said circuits and meters the service at the primary distribution voltage.
- 2.2 <u>Primary Service with Secondary Metering</u> (The availability of this provision is limited to existing customers at the locations served as of the effective date of this tariff). When a customer takes service at a primary distribution voltage, but the Company elects to meter service at the secondary distribution voltage, energy charges will be billed in accordance with the rate for secondary service.
- 2.3 <u>Separately Metered Space Heating</u> (The availability of this provision is limited to existing customers at the locations served as of the December 21, 1993). When a customer takes general service under this classification and:
  - (1) permanently installed electric comfort heating equipment, with rated capacity of not less than five kilowatts, is the sole source of comfort heating in the segregated space in which it is installed, and
  - (2) this electrically heated space is normally heated continuously throughout the heating season, then the customer may elect separate metering of the energy used in the segregated space for the following purposes:

comfort heating
air conditioning
water heating
cooking, if the sole means of cooking
