This monthly minimum charge includes the Delivery Service Rates, Interstate Pipeline Fixed Charge Rates and Commodity Cost of Gas Rates set forth in the Monthly Rate Section above. The \$2,545 minimum charge is equal to the summation of the Delivery Minimum Charge of \$773.60 Interstate Pipeline Minimum Fixed Charge of 752.30 and a Commodity Cost of Gas Minimum Charge of \$1019.10. In addition to the minimum charge, customers may be required to pay a surcharge when service is taken from a main extension constructed in accordance with Rule 10, General Information.

COMMODITY COST ADJUSTMENT CLAUSE:

The Commodity Cost of Gas set forth in the Monthly Rate Section above shall be subject to a Commodity Cost Adjustment per Therm of gas supplied hereunder when changes from the base cost occur as explained in Rule 17 of this schedule.

BTU ADJUSTMENT:

Volumes of gas registered at the customer's meter, in Ccf, will be adjusted for Btu content, in Therms, as stated in Rule 14.3.
