On each day during the term of service hereunder, the Customer shall deliver or cause to be delivered at the Receipt Point the Average Daily Transportation Quantity, and the Company will deliver to the Customer the Daily Delivery Quantity. The Customer shall provide to the Company by the 15th of every month notice of the Daily Transportation Quantity Scheduled for delivery at the Receipt Point each day of the succeeding month for the Customer's account. The Customer may modify this Schedule by notifying the Company in writing no less than 24 hours before delivery at the Receipt Point. In the event the Customer tenders quantities in excess of the Average Daily Transportation Quantity, the Company may, in its sole discretion, transport such excess volumes if sufficient capacity is available in its system.

Price per therm to be determined at the sole discretion of the Company. The Effective Rate will be shown on the Statement of Rates and Charges for Natural Gas Vehicle Service Classification Nos. 9, 10 and 11, filed with the Public Service Commission not less than three (3) business days prior to the effective date of the Statement.

Heating Value Adjustment:

The volume of gas registered by the Customer's meter in 100 Cu. Ft. will be converted to therms as explained in Rule II.3G. The Customer's meter is that owned by the Company and located at the inlet to the refueling station.

Minimum Charge: \$37.74 per meter, per month.

Increase in Rates and Charges:

The rates and charges under this Service Classification are increased by the applicable percentage as explained in Rule III.2 for service supplied within the municipality where the customer is taking service.

## Other Charges and Credits:

In addition to the rate stated above, the Customer's bill may be adjusted monthly for applicable charges and refunds, including the Merchant Function Back Out Credit which is shown on the Statement of Gas and Pipeline Costs and Adjustments and explained in Rule III.1.
