#### 58. SERVICE CLASS DEFERRAL CREDIT

58.1 Pursuant to the Order of the Public Service Commission ("Commission") dated March 15, 2018 in Case No.17-E-0238, the Company was directed to establish a credit/surcharge for its deferral accounts. The credits below, by service classification, establish factors for PSC No. 220 and are included in each service classifications stated per kWh and per kW charge as applicable.
