RESIDENTIAL SERVICE (Cont'd)

Gas Cost Adjustment:

The charges set forth herein for Gas Interconnection, Gas Transportation, Gas Supply and Load Balancing shall be charged through a gas cost adjustment per therm supplier hereunder as set forth in 2.XII of this tariff.

Minimum Charge:

For Sales Service \$20.00 per meter, per month, plus applicable revenue taxes. Low Income customers \$15.00 per meter, per month, plus applicable revenue taxes. Low Income customers, Enhanced, \$10.00 per meter, per month, plus applicable revenue taxes. Low Income customers, Enhanced Plus, will pay a \$5.00 minimum charge per meter, per month, plus applicable revenue taxes. Low Income customers, Plus, will pay a \$0.00 minimum charge per meter, per month, plus applicable revenue taxes

For customers taking Reserved Unbundled Transportation Service and delivering gas to the company at Empress, Alberta, Canada the minimum charge shall be \$20.00 per meter per month plus the Demand Charge of TransCanada PipeLines Limited plus applicable revenue taxes. Low Income customers will pay a \$15.00 minimum charge per meter, per month, plus applicable revenue taxes. Low Income customers, Enhanced, will pay a \$10.00 minimum charge per meter, per month, plus applicable revenue taxes. Low Income customers, Enhanced Plus, will pay a \$5.00 minimum charge per meter, per month, plus applicable revenue taxes. Low Income customers, Plus, will pay a \$0.00 minimum charge per meter, per month, plus applicable revenue taxes

For customers participating in an Agency Gas Transportation Service Agreement, the minimum shall be \$20.00 per meter per month plus applicable revenue taxes. Low Income customers will pay a \$15.00 minimum charge per meter, per month, plus applicable revenue taxes. Low Income customers, Enhanced, will pay a \$10.00 minimum charge per meter, per month, plus applicable revenue taxes. Low Income customers, Enhanced Plus, will pay a \$5.00 minimum charge per meter, per month, plus applicable revenue taxes. Low Income customers, Plus, will pay a \$0.00 minimum charge per meter, per month, plus applicable revenue taxes.

Contract Administration Charge:

For transportation customers a charge of \$125.00 per account, per month, plus applicable revenue taxes shall be billed to individual customers..

Taxes:

The rates and charges are subject to the tax factor as explained in 2.XIV.

Terms of Payment:

Net cash. The amount due if bills are not paid by the due date is arrived at as outlined in 2.III.B. of this tariff.
