- L. Annual Cost of Gas Reconciliation for Green Gas Renewable Natural Gas ("RNG") Rider Service Classification Nos. 1A, 1B, 1B-DG, 2, 3, 15, 16, and 17

A surcharge or refund (adjusted for simple interest at the Commission's other customer capital rate) to recover Green Gas RNG Cost of Gas under-collections or refund Green Gas RNG Cost of Gas overcollections from Green Gas RNG Rider customers served under SC 1, 2, 3, 15, 16, and 17 shall be computed by comparing total annual actual Green Gas RNG Cost of Gas to annual actual Green Gas RNG recoveries.

The total annual imbalance for the GAC year (12 months ended August 31) will be recovered from or refunded to customers participating in the Green Gas RNG program by dividing the total imbalance (including simple interest at the Commission's other customer capital rate) by forecast Gas Sales for Green Gas RNG rider customers for the twelve-month period January 1 through December 31 following the end of the previous GAC year. The Annual Green Gas RNG Cost of Gas Imbalance Surcharge of Refund will be included on the Statement of Green Gas RNG Cost of Gas for SC 2, 3, 15, 16 and 17 customers that elect the percentage offered in Rule III.9. The Annual Green Gas RNG Cost of Gas Imbalance Surcharge of Refund will be included on the Statement of Green Gas RNG Annual Cost of Gas Imbalance for SC1 customers and for SC 2, 3, 15, 16 and 17 customers that elect the fixed dollar election in accordance with Rule III.9.
