## Earnings Adjustment Mechanism

The Earnings Adjustment Mechanism ("EAM") allows the Company to recover earned gas EAM positive revenue adjustments through an EAM surcharge over the twelve months beginning April 1, 2021 (adjusted for the Company's pre-tax WACC).

The per therm rate will be calculated by allocating the earned incentives to SC 1, 2, 3, 9, 15, 16, and 17 firm sales and SC 5 firm transportation customers service class based on percentage of gas deliveries. The EAM will appear on the Statement of Earnings Adjustment Mechanism to be filed not less than three (3) days prior to the effective date.
