The Customer Charge is the charge for the first 500 Therms or less as set forth in PRICE (Per Month), per meter, plus the Bill Issuance Charge, per bill if applicable. The charge for the first 500 Therms or less and the Bill Issuance Charge, if applicable, will appear on the Customer's bill whether or not any gas was used during the billing period.

## **MINIMUM CHARGE:**

The Customer shall be required to purchase a minimum quantity of 40,000 therms per billing month for the November through March period. If this minimum is not met, the deficiency shall be billed at the applicable price as set forth on the monthly Statement of Gas Interruptible Transportation Rate Adjustment filed pursuant to this Schedule, or any superseding issues thereof.

In the event that service is interrupted by the Company in accordance with the terms of this Service Classification, then the Minimum Charge shall be multiplied by the ratio of the number of days that service is available to the customer for a full day to the total number of days in the service period.
