The operation of this equipment must have an average annual load factor of 50% or greater. Load factor shall equal annual usage divided by (peak winter day use times 365 days). A separate meter will be installed for gas supplied under this service classification, and the use of gas measured by this meter for other than that above described is expressly prohibited. See Special Provisions.

#### **Character of Service:**

Natural gas of not less than 975 Btu, dry basis, per cubic foot at a pressure of not less than four inches of water column gauge, as measured at the Customer's end of the service line.
