- (6) Winter Bundled Sales Service ("WBSS")
 - A) The Winter Bundled Sales Service, described below, that was in effect for the period December 1, 2016 through March 1, 2017, was discontinued as of March 1, 2017. A Marketer serving a Firm Service Classification No. 9 Customer or Firm Small Customer Aggregation Group will be provided this service in conjunction with the Daily Delivery Service to meet the requirements of its firm transportation Customers.

Each month Marketers will be given the option to utilize base load supply to meet their daily requirement. Marketers must notify the Company if they will exercise this option to elect base load monthly supply by the fifth (5^{th}) business day prior to the start of the next month.

Marketers will be assessed pipeline demand/reservation charges for the entire duration of this modified WBSS program but will only be charged for gas commodity in the months in which they elect the base load monthly supply as described above. Details of this modified WBSS program will be set forth in the Company's GTOP.

- B) The existing WBSS program, discontinued as of November 1, 2016, is described below: For a Marketer electing the WBSS option (such an electing Marketer will also be referred to as a "WBSS participant"), the Company will provide to the Marketer the Winter Bundled Sales Volume ("WBSV") as defined and determined in the manner set forth below:
 - a) The Company will determine the total amount of WBSV available to qualified Marketers annually. For each Winter Period, the Company will notify qualified Marketers of the WBSV available for the upcoming Winter Period on or before March 9th of each year. For each Winter Period, a Marketer may elect up to its allocated WBSV by notifying the Company within 10 business days of the Company providing notice of the quantity of WBSV available. The Company is under no obligation to provide WBSV to Marketers who fail to notify the Company within the above schedule
 - b) The WBSS participant's allocated WBSV, including an amount to be retained as an allowance for losses as set forth on the monthly Statement of Rate for Service Classification ("SC") No. 9, will be the ratio of the sum of the MDQ's of the WBSS participant's SC No. 9 Firm Transportation Customers to the total MDQ's of all the firm transportation Customers taking service under SC No. 9 (excluding Power Generation customers, if any). A WBSS participant may elect to subscribe to its entire allocated WBSV, or a lesser amount. The WBSS participant is required to purchase the subscribed WBSV from the Company during the Winter Period.
